## **Transactive Discussion Family Separation**

Please read the following prompt and quotes. In small groups, discuss the questions below.

In the last few years, immigration in the United States immigration policies have been in the national and international spotlight. One policies that gained a lot of attention are Family Separation policies. Under the Obama administration (2008-2016), families crossing the border without documentation were detained together. In addition, individuals were often granted bail, assigned legal counsel, and granted asylum when necessary. On April 6, 2018, the Trump administration enacted a "Zero Tolerance" policy that criminally prosecuted all individuals who crossed the border illegally and separated family units. Babies to 17-yearolds were classified "unaccompanied alien children." This policy detained everyone who crossed the border while they awaited sentencing for long stretches of time months. Although the policy was enacted in April of 2018, evidence shows it started unofficially in 2017.2 In June 2018, after much criticism and protest, President Trump signed an executive order to end family separation at the border. However, family separations continued even after the formal end of the policy. Children and adolescents taken from their families were placed in overcrowded and poorly resourced detention centers. Despite court orders that mandated families be reunited within 30 days of separation, many children remained separated from their guardians. Some parents were even deported without their children.

Trump's zero tolerance policy was very controversial. Supporters of the policy believe it was a powerful deterrent to people who wanted to enter America without documentation. They also believe there should be consequences if you break the law. Opponents of the policy believe it was cruel and unusual punishment to separate families and that the practice traumatized children in potentially irreversible ways. Many opponents also believe the policy was racist, as the Trump administration disproportionately targeted Latinx immigrants.<sup>3</sup> The administration did not enact similar policies towards other immigrant populations from Europe and Asia, despite the high levels of undocumented individuals living in the U.S.<sup>4</sup>
